

## Corporate Carbon Footprint according to ISO 14064



### What does the Corporate Carbon Footprint include?

What is the carbon footprint of your organization or company? Do you meet your own climate protection requirements? Is your community a climate pioneer?

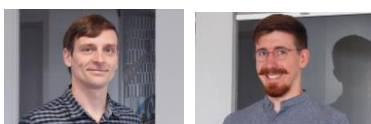
Disclosing the Corporate Carbon Footprint (CCF) is an effective tool to meet the customers, business partners or investors. In Germany, tracking the CO<sub>2</sub> emissions generated by a company is not mandatory - but a look at neighboring European countries shows a different picture: For example, companies in the logistics sector that transport goods or people to or from France are obliged to inform the service recipient about the CO<sub>2</sub> emissions of the transport process. In the UK, all listed companies have had to report on their greenhouse gas emissions since October 2013, and in Switzerland, energy-intensive companies not covered by emissions trading can be exempted from the CO<sub>2</sub> tax - tied to regular reporting and mandatory reductions in their greenhouse gas emissions.

Even if it is not expected that publishing CO<sub>2</sub> emissions will become mandatory for companies at the EU level in the near future, voluntary emissions reporting holds major competitive advantages.

If the information provided by your CCF is reliable, transparent and comparable, your customers, business partners and shareholders will receive a clear picture of your company's carbon footprint, business partners and shareholders a reliable basis for decision-making. And verifying your CCF gives you the certainty that you have "not overlooked anything": you can communicate credibly.

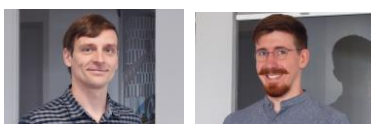
# Important information
